### 1. DEFINED TERMS:

The term "Show" refers to the 2022 Science Symposium and Flats Expo, scheduled for November 4-5 at the PGA National Resort, Palm Beach, FL. This Show is owned and produced by Bonefish & Tarpon Trust, referred hereinafter as the "Organizers". The term "Exhibitor" shall be defined as the company or person that applied for exhibit space rental and agreed to enter into this contract upon acceptance by the Organizers in the manner stated below

### 2. TIMES:

The show will be open to the public at the following times: Friday November 4, 2022; through Saturday November 5, 2022; 9:00 AM-5:00 PM. The Show venue will be available for Exhibitors to assemble exhibits prior to the show Thursday November 3, 2022; 9:00 AM to 5:00 PM. All exhibits must be set-up and exhibitors must be on site no later than 12:00 PM on Thursday. Late arrivals will not be permitted to set up during show hours. No part of an exhibit may be removed prior to 5:00 PM Saturday, November 5, 2022. All exhibits must be completely removed by 1:00 PM Sunday, November 6.

### 3. APPLICATION FOR SPACE:

No right to allocation of space may be derived from the application. In special cases the Organizers may decide not to confirm an application, to allocate less space than has been applied for, to alter allocated space or to withdraw an allocation without the Exhibitor being entitled to claim compensation for damage incurred.

### 4. SPACE ASSIGNMENTS AND SUBLEASE:

Organizer will assign exhibit space on a first-come, first-served basis. Organizer will make a best effort to accommodate any exhibitor booth space requests and special needs, but reserves the right to change the location assignment any time prior to the exhibition dates as deemed necessary. Exhibitor will not sublet exhibit space or equipment provided by the Organizer, or assign this lease.

### 5. PAYMENT TERMS:

Payment is due at the time of application. If full payment is not received by October 5, 2022, exhibitor space is subject to forfeiture and reassignment at the sole discretion of Show Management. Unless we are notified otherwise, your signature authorizes Bonefish & Tarpon Trust to process your credit card for the total of the booth space requested on agreement.

### 6. CANCELLATION OF CONTRACT:

Exhibitor has the right to cancel this agreement at any time by written notice to the Organizer. Full payment is due by October 5, 2022. **Cancellations on or prior to October 15, 2022 will receive an 80% refund; cancellations after October 15, 2022 will not receive a refund.** Under all circumstances, Organizer reserves the right to fill any exhibit space cancelled by an Exhibitor. If full payment is not received by end of business October 15, 2022. Organizer has the right to award your reserved space to another vendor and will not guarantee booth availability or your choice of booth location.

### 7. CHARACTER OF EXHIBIT:

The Organizers reserve the right to prohibit or remove any exhibit or Exhibitor and to permit only such matter and conduct, as it shall approve. This reservation covers persons, things, conduct, printed matter and all things that affect the character of the exhibition. The Exhibitor will not obstruct or hinder the Organizers in preventing or removing forthwith any matter, conduct or thing, which is considered objectionable.

### 8. RISKS:

Exhibitor expressly assumes all risks associated with, resulting from or arising in connection with Exhibitor's participation or presence at the Show, without limitation. Neither the Organizers nor the Show Facility shall be liable for any losses or damages.

### 9. INSURANCE:

The Exhibitor shall hold the Organizers and Show facility harmless from any damage, expense or liability arising out of the Exhibitor's occupancy of the licensed space whether or not such activities shall occur in the licensed space, the building, the parking lot or elsewhere.

### 10. CANCELLATION OR POSTPONEMENT:

In the event that the event is postponed because of any occurrence not occasioned by the conduct of the Organizer or Exhibitor, whether by an act of nature, the result of war, riot, civil commotion or the conduct of any person not party to this lease, the performance of the parties under this agreement will be excused for such period as is reasonably necessary after such occurrence to remedy the effect thereof. In the event that such occurrence results in cancellation of the event, the obligations of the parties under this agreement will be terminated and all rental payments made under this lease will be refunded to Exhibitor less a pro rata share of expenses actually incurred by the Organizer.

### 11. LABOR AGREEMENTS:

The Exhibitor agrees to observe all union contracts and labor relation agreements in force, agreements between the Organizers, official contractor serving companies and the building in which the Show will take place and the labor laws of the jurisdiction in which the building is located.

### 12. LIABILITY:

This agreement does not constitute a partnership, employer-employee relationship, joint venture or agency between the Organizer and Exhibitor. Exhibitor or third party representative shall be fully responsible to pay for any and all damages to PGA National Resort or Organizer, their owners or managers, which results from any act or omission of Exhibitor or third party representative. Exhibitor or third party representative agrees to defend, indemnify and hold harmless, PGA National Resort, Organizer and their respective owners, managers, officers or directors, agents, employees, subsidiaries and affiliates, from any damages or charges resulting from their use of the property, including attorney fees and expense. Exhibitor's or third party representative's liability shall include, without limitation, all losses, costs, damages, or expenses arising from or out of or by reason of any accident, property damage, bodily injury or other occurrences to any person or persons or property, including the Exhibitor or third party representative, its agents, employees and business invitees which arise from or out of the Exhibitor's or third party representative's occupancy and use of the exhibition premises, PGA National Resort, or any part thereof. Exhibitor's liability should include all losses, costs, damages or expenses arising from or out of or by reason of any accident or bodily injury or other occurrences to any person or persons, including the Exhibitor, its agents, employees and business invitees which arise from or out of the Exhibitor's occupancy and use of the exhibition premises.

### 13. GENERAL:

The Organizers shall have full power in the interpretation and enforcement of all Terms and Conditions contained herein and the power to make such amendments thereto and such further rules and regulations governing participation in the Event as they consider necessary for the proper conduct of the Show. If the Exhibitor fails to make any payments at the time appointed, all rights of the Exhibitor shall cease and terminate. Until the Organizers accept this application, the Exhibitor shall be entitled to the return of the rent paid upon notice in writing to the Organizers. In the event that any provision of these Terms and Conditions shall be found to be illegal or otherwise unenforceable, the balance of these Terms and Conditions shall be read as if the illegal or unforeseeable Term and Condition rule is not contained herein. There is no representation, warranty or condition made by or binding upon the Organizers affecting the subject matter of this agreement of the said space other than as expressed herein. Nothing herein shall be construed as constituting the Exhibitor and Organizers, partners, joint ventures or agents of one another. The Exhibitor has read and understands the Terms and Conditions and understands that this application and the contract resulting from it will be subject to these Terms and Conditions. The Organizers reserve the right to determine the eligibility and appropriateness of exhibits before acceptance of this contract. This contract and any dispute that may arise here from shall be interpreted and governed in accordance with Florida law.
